DOMTAR- locks and road work on the club

As you may have noticed, from the start of the deer season on November 11th, some of the locks on the club roads have gone missing. If any member has information about the missing locks, please inform the directorate. Your help in monitoring the club- including locks, the sign-in shack and other property- is appreciated.

Chapter 6- Duties of Members

6.6 Members have the obligation to collaborate in the guarding of the territory.

As mentioned in the Fall Newsletter:

- There is a new road on the 257 that accesses the south-west part of the club and connects with the existing Rd 70 on the club. Posts are put in and a cable and lock will be installed. Members will not have a key as it is limited access until further notice.
- The new road that was cut last year (closest to the cemetery) will have cement blocks installed with a cable and a lock. Members will not have a key as it is limited access until further notice.

The directorate is in communications about the missing locks as well as work on the club.

Registration of big game

In order to keep keep track of the big game taken on the club, if any

member harvested a moose, deer or bear in 2023, please advise any member of the directorate of the following:

- Species (doe, buck, bull, sow or boar)
- Date taken

This year, there was not a sign-in and registration for big game in the sign-in shack.

12.2 Any member who kills a deer, a moose or a bear on the territory of the Association has the obligation to report his hunt or capture to a member of the board of directors...

Hunting with dogs

Hunting with dogs on the club is forbidden except for small game hunting as outlined in Chapter 13 of the Regulations.

Chapter 13 – Small game hunting

13.1 Hare hunting with the help of Beagle dogs trained for these purposes is authorized for the period between the end of the latest of authorized season for deer, bear or moose and in compliance of the hare hunting season according to the regulations in force.
